Flammability Combustible. May evolve toxic gases (carbon oxides, hydrocarbons) when heated to decomposition.

Fire and Explosion

Combustible. Evacuate area and contact emergency services. Toxic gases (hydrocarbons, carbon oxides) may be evolved when heated. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.

Extinguishing Dry agent, carbon dioxide or foam. Prevent contamination of drains or waterways. Absorb runoff with sand or similar.

Spillage If spilt (bulk), contact emergency services where appropriate. Wear splash-proof goggles, viton/nitrile gloves, a Type

A (Organic vapour) respirator (or Air-line respirator in confined areas), coveralls and rubber boots. Ventilate and clear area of all unprotected personnel. Eliminate all ignition sources. Absorb spill with sand or similar, collect and place in sealable containers for disposal.

Handling Use safe work practices to avoid eye or skin contact and inhalation. Observe good personal hygiene. Prohibit eating, drinking and smoking in contaminated areas. Wash hands before eating. Remove contaminated clothing and protective equipment before entering eating areas.

Storage Store in cool, dry, well ventilated area, removed from oxidising agents (eg. hypochlorites), acids (sulfuric acid), heat

sources and foodstuffs. Ensure containers are adequately labelled, protected from physical damage and sealed when not in use. Large storage areas should have appropriate ventilation systems.

Ventilation Do not inhale vapours. Use in well ventilated areas. In poorly ventilated areas, mechanical extraction ventilation is recommended.

Health Hazard

Summary

Toxic - irritant. This product has the potential to cause acute and chronic health effects. Use safe work practices to avoid eye or skin contact and vapour generation/inhalation. Chronic exposure to organic solvents may result in liver, kidney and CNS damage.

Eye Irritant. Contact may result in lacrimation, irritation, pain, redness and conjunctivitis. Prolonged contact - corneal burns and possible permanent damage.

Inhalation Irritant - toxic. Over exposure may result in irritation of the nose and throat, headache, fatigue, loss of appetite, nausea and vomiting. At high levels; dizziness, breathing difficulties, pulmonary oedema and unconsciousness. Chronic exposure may cause liver, kidney and CNS damage.

Skin Irritant. Prolonged contact may result in drying and defatting of the skin, rash and dermatitis. Toxic effects may result from skin absorption.

Ingestion Toxic. Ingestion may result in nausea, vomiting, abdominal pain, dizziness, fatigue and diarrhoea. Large doses may cause kidney and liver damage, unconsciousness and convulsions. Aspiration into lungs may cause chemical pneumonitis and pulmonary oedema.

Environment If aromatic hydrocarbons are released to soil, they will evaporate from near-surface soil & leach to groundwater.

Biodegradation occurs in soil & groundwater but may be slow, especially at high concentrations, which can be toxic to microorganisms. Will exist largely as vapour in air. Half life in atmosphere depends on particular hydrocarbon (eg 1-2 days (xylene); 3 hrs-1 day (toluene)).

Disposal

Wearing the protective equipment outlined, ensure all ignition sources are extinguished. For small quantities, absorb on paper, sand or similar and evaporate under a fume cupboard or open area. For large volumes, atomise into incinerator (mixing with more flammable solvent if required) or recycle by gravimetric separation, distilling & reusing. Contact the manufacturer for additional information if required.

Additional Information

Flammable or combustible liquids with explosive limits have the potential for ignition from static discharge. Refer to AS 1020 (The control of undesirable static electricity) and AS 1940 (The storage and handling of flammable and combustible liquids) for control procedures.
